प्रभाव, जुगाड़ के दम पर तैनाती पड़ी महंगी!

हाईकोर्ट ने दिए दो महिला अध्यापिकाओं के जिले से बाहर तैनाती के आदेश

शिमला, 26 अगस्त (जनसंता)।
प्रभाव और जुगाड़ के दम पर पूरी नौकरी के दौरान अपनी तैनाती शिमला और उसके आसपास के इलाकों में ही करवाना दो महिला अध्यापिकाओं को महंगा पड़ गया। प्रदेश हाईकोर्ट ने सुधवार को दोनों अध्यापिकाओं को दो सप्ताह के भीतर जिले से बाहर तैनात करने के आदेश दिए हैं।
हाईकोर्ट ने शिक्षा विभाग को आग्रह किया है कि इन दोनों की तैनाती अर्थात् पूर्ण होनी चाहिए न कि इन्हें समायोजित करने की कोशिश की जानी चाहिए।
अदालत ने शिक्षा विभाग को बतावलें कि इस मिलीभगत व साठसठ के तंत्र को तोड़ने के भी आदेश दिए हैं। ये आदेश प्रदेश हाईकोर्ट के न्यायाधीश न्यायमूर्ति त्रिलोक सिंह चौहान और न्यायमूर्ति

ज्योत्सना रेवाला दुआ ने जारी किए।
याचिकाकर्ता अध्यापिका ने याचिका में कहा था कि उसकी तैनाती 16 अगस्त 2017 को राजकीय वरिष्ठ माध्यमिक पाठशाला संजौली में हुई थी व 23 जनवरी 2020 को उसका तबादला टिगोय में एक डीओ नोट के आधार पर कर दिया। इसे रद्द किया जाए। इसके साथ ही उन्होंने कहा कि जिस अध्यापिका को उनकी जगह बदला गया है उसने जुलाई 2013 में ही अपनी तैनाती वरिष्ठ माध्यमिक पाठशाला में करवाई और छह महीने के बीच उसने डीओ नोट के आधार पर अपना तबादला एक जनवरी 2020 को संजौली स्कूल में करवा लिया।
इस बातव शिक्षा विभाग ने अपने तबादला आदेशों को

रहा करार देते हुए कहा के ये आदेश सक्षम अधिकारी से मंजूरी के बाद ही जारी किए गए हैं। वहीं, टिगोय से संजौली तबादला करवाने वाली अध्यापिका ने स्वील दी कि उसने स्वास्थ्य के आधार पर अपना तबादला करवाया है।
अदालत ने सभी पक्षों की दलीलें सुनने के व दस्तावेजों का आकलन करने पर पाया कि शिक्षा विभाग ने इन आदेशों को प्रशासनिक जरूरत के मुताबिक नहीं बल्कि संजौली में जिस अध्यापिका का तबादला किया उसे समायोजित करने के लिए किए हैं। अध्यापिका ने शिक्षा मंत्रि को जनवरी 2020 को पत्र लिखकर कहा कि उसे 2018 में मरिस्तका का अधरंग पड़ा था और इसी आधार पर उसका तबादला टिगोय से संजौली कर दिया जाए।

अदालत ने कहा कि टिगोय के लिए डीओ नोट के आधार पर ही जुलाई 19 में इस अध्यापिका ने आपसी सहमति के साथ तबादला करवाया था। जहिर है कि ये तबादला नीति के तहत करवाया गया था तकि इसे इस नीति का लाभ मिल सके। अदालत ने यह भी कहा कि प्रभावशाली सरकारी कर्मचारी जिला और तहसील मुख्यालयों में अपनी तैनाती करवाना चाहते हैं और अपनी नौकरी की पूरी अवधि शहर या इसके आसपास के इलाकों में ही गुजार देते हैं। दोनों अध्यापिकाओं ने भी यही तरीका अपनाया और आपसी सहमति से एक दूसरे की जगह अपने तबादले कराती रही। खास बात यह है कि दोनों को कार्रवाई के दौरान शिमला के 35 किमी दायरे में तैनात रही। यह कार्रवाई सरकार या शिक्षा विभाग की मिलीभगत के बिना संभव नहीं है। अदालत ने इस तबादले को गलत मंशा से किया करार दिया।

कांगड़ा जिले में सुधवार सुबह टांडा अस्पताल में कोरोना संक्रमित एक महिला की मौत हो गई। यह जिले की छठी जबकि प्रदेश की 30वीं मौत है। प्राप्त जानकारी के मुताबिक मृतका (45) पालमपुर के परेड बांब वी रहने वाली थी। एक निजी अस्पताल में आस्पेशन के बाद जब उसका स्वास्थ्य बिगड़ा तो उसे 12 अगस्त को

टांडा अस्पताल में भर्ती करवाया गया। दो रोज पहले 24 अगस्त को कोविड-19 की जांच में महिला संक्रमित निकली। सुधवार सुबह उसने दम तोड़ दिया।
धर कोरोना से चंबा शहर के निवाले जुलाकड़ी मोहल्ले के निवासी 60 साल के एक बुजुर्ग को कोरोना से अमृतसर में मौत हो गई। चंबा जिले में यह चौथी मौत है। स्वास्थ्य विचारों को लेकर इस व्यक्ति को पहले चंबा के मेडिकल कालेज लाया गया वहां उसकी कोविड-19 की जांच के बाद उसे टांडा भेज दिया गया मगर परिजन उसे अमृतसर ले गए। यहां मृत्यु के बाद उसकी रिपोर्ट में संक्रमण की पुष्टि हुई है।
वहीं, प्रदेश में सुधवार को संक्रमण के 167 नए मामले

सामने आए। जबकि आंकड़ा 5300 पार जा पहुंचा है। आज सबसे अधिक मामले सिरमौर जिले से सामने आए। यहां पर 58 संक्रमितों की पुष्टि हुई जबकि सोलन जिले में 29, बिलासपुर में 16, शिमला में 15, चंबा में 13, कुल्लू और जना में 12-12, कांगड़ा में 11 जबकि किन्नौर में एक मामले सामने आया है। अतिरिक्त मुख्य उच्च स्वास्थ्य अरुड़ी धीमान ने पुष्टि करते हुए बताया कि आज कोरोना से 62 लोग ठीक भी हुए। उन्होंने कहा कि अब तक प्रदेश में 3810 लोग ठीक हो चुके हैं जबकि सक्रिय मामलों का आंकड़ा 1428 तक जा पहुंचा है।
