याचिकाकर्ता अध्यापिका ने याचिका में कहा था कि उसकी तैनाती 16 अगस्त 2017 को राजकीय चरिष्ठ माध्यमिक पाठशाला संजीली में हुई थी व 23

जनवरी 2020 को उसका तबादला ठियोग में एक डीओ नोट के आधार पर कर दिया। इसे रद्द किया जाए। इसके साथ ही उन्होंने कहा कि जिस अध्यापिका को उनकी जगह बदला गया है उसने जुलाई 2013 में ही अपनी तैनाती चरिष्ठ माध्यमिक

पाठशाला में करवाई और छह महीने के बीच उसने डीओ नोट के आधार पर अपना तबादला एक जनवरी 2020 को संजीली स्कल में करवा लिया।

इस बावत शिक्षा विभाग ने अपने तचादला आदेशों को

सही करार देते हुए कहा के ये आदेश सक्षम अधिकारी से मंज़री के बाद ही जारी किए गए हैं। वहीं, ठियोग से संजीली तबादला करवाने वाली अध्यापिका ने दलील दी कि उसने स्वास्थ्य के आधार पर अपना तबादला कराया है।

अदालत ने सभी पक्षों की दलीलें सनने के व दस्तावेजों का आकलन करने पर पाया कि शिक्षा विभाग ने इन आदेशों को प्रशासनिक जरूरत के मुताबिक नहीं बलकि संजीली में जिस अध्यापिका का तबादला किया उसे समायोजित

करने के लिए किए हैं। अध्यापिका ने शिक्षामंत्री को जनवरी 2020 को पत्र लिखकर कहा कि उसे 2018 में मस्तिष्क का अधरंग पडा था और इसी आधार पर उसका तबादला ठियोग से संजीली कर दिया जाए।

अदालत ने कहा कि ठियोग के लिए हीओ नोट के आधार पर ही जलाई 19 में इस अध्यापिका ने आपसी सहमति के साथ तबादला कराया था। जाहिर है कि से तबादला नीति के तहत कराया गया था ताकि इसे इस नीति का लाभ मिल सके। अदालत ने वह भी कहा कि प्रभावशाली सरकारी कर्मचारी जिला और तहसील मुख्यालवों में अपनी तैनाती करवाना चाहते हैं और अपनी नौकरी की पूरी अवधि शहर या इसके आसपास के इलाकों में ही गुजार देते हैं। दोनों अध्यापिकाओं ने भी यही तरीका अपाया और आपसी सहमति से एक दूसरे की जगह अपने तबादले कराती रही। खास बात यह है कि दोनों परे कार्यकाल के दौरान शिमला के 35 किमी दावरे में तैनात रही। वह कारगुजारी सरकार वा शिक्षा विभाग की मिलीभगत के बिना संभव नहीं है। अदालत ने इस तबादले को गलत मंशा से किया करार दिया।

इधर कोरोना से चंबा शहर के निवले जलाकड़ी मोहल्ले के निवासी 60 साल के एक बुजुर्ग की कोरोना से अमृतसर में मौत हो गई। चंबा जिले में यह चौथी मौत है। स्वास्थ्य विकारों को लेकर इस व्यक्ति को पहले चंबा के मेडिकल कालेज लाया गया यहां उसकी कोविड-19 की जांच के बाद उसे टांडा भेज दिया गया मगर परिजन उसे अमृतसर ले गए। यहां मृत्य के बाद उसकी रिपोर्ट में संक्रमण की पुष्टि हुई है।

वहीं, प्रदेश में बुधवार को संक्रमण के 167 नए मामले

टांडा अस्पताल में भर्ती करवाया गया। दो रोज पहले 24 सामने आए। जबकि आंकड़ा 5300 पार जा पहुंचा है। जबकि एक कोरोना संक्रमण का मामला नाहन से सामने आज सबसे अधिक मामले सिरमीर जिले से सामर्ने आए। यहां पर 58 संक्रमितों की पृष्टि हुई जबकि सोलन जिले में 29, बिलारापुर में 16, शिमला में 15, चंबा में 13, कुल्लु और ऊना में 12-12, कांगड़ा में 11 जबकि किन्नीर में एक मामला सामने आया है। अतिरिक्त मुख्य सचिव स्वास्थ्य आरडी धीमान ने पृष्टि करते हुए बताया कि आज कोरोना से 62 लोग ठीक भी हुए। उन्होंने कहा कि अब तक प्रदेश में 3810 लोग ठीक हो चुके हैं जबकि सक्रिय मामलों का आंकड़ा 1428 तक जा पहुंचा है।

नगर निगम में परिवर्तन की मांग की गई है। उन्होंने कहा कि मंदी शहर में उपलब्ध जगह सीमित होने के कारण इसका विकास नहीं हो पाया है इस वजह से शहर के वर्तमान भवनों को ऊँचा किया जा रहा है जो न केवल नागरिक खेवाओं को भी प्रभावित कर रहा है बल्कि यहां के ऐतिहासिक इतिहास और धरोहरों को भी खतरा बनता जा रहा है इसलिए आवश्यक है समीप के ग्रामीण क्षेत्रों के विलय से नगर निगम के माध्यम से शहर के अनुरूप विकास के स्थान पर समसतर विकास किया जाए।
